Explain the need for the change

A new subject heading, "Anatomy & Physiology," is moving forward right now. The Physiology department has submitted proposals to move their courses to the new subject heading, which will be administered by the Kinesiology department in the School of Education. This proposal will move Kinesiology 337 to the new subject heading. Housing the course under the current heading of Kinesiology creates confusion on the part of students attempting to enroll in the course. By housing anatomy and physiology under the same subject heading, this will hopefully eliminate that confusion. It will also alleviate confusion on student transcripts - some graduate programs will not accept an anatomy course labeled as kinesiology.
